LETTER FROM THE BOARD PRESIDENT

The Tiny Tim Center continues to shine with the excellent Preschool Programs and Therapeutic Services that are provided on a daily basis. During 2011, we added a full day preschool program that was a hit with parents. In addition to this five day program, it is also a 12 month program. It is amazing how quickly this program has grown. Over the years, parents have asked for a program like this, but it was something that we could never get off the ground until 2011.

One of the highlights for 2011 was receiving a multi-year grant from Social Venture Partners (SVP) of Boulder County. SVP is a group of individuals and professionals that actively contribute their expertise, time and money to assist Boulder County non-profits. Besides the monetary grant, we receive significant in-kind work from this group of wonderful individuals. One of the many areas that SVP is assisting The Tiny Tim Center with is to develop a strategic plan. The strategic plan that had been in place ended in 2011, so it was important to have the assistance of SVP to develop our plan for the next three to five years. SVP thought that before we put together our plan, we should hold several focus groups. So as a result, we were able to hold two focus groups. Those invited to participate were community leaders, past and present board members, donors, past and present parents, teachers, therapists and administrative staff. Great input and information came out of these focus groups! With a lot of hard work and many man hours, the information obtained during the focus groups helped the administrative staff and board of directors develop what I feel is one of the best strategic plans The Tiny Tim Center has ever had in place.

We were fortunate that during 2011 we gained several very good new board members. These new board members are community leaders and parents of former and current students. All of our board members are very talented and are excited to help lead The Tiny Tim Center to the next level.

As you can see from the financial information enclosed, 2011 was another challenging financial year for The Tiny Tim Center. Our fundraising and donations fell severely short of our budgeting expectations. Due to this short fall, we had to look hard at our expenses and our ability to create additional income as we prepared our 2012 budget. We can only hope the economy will recover, so that our fundraising, donations and grant efforts will be positive for 2012, so that we can again operate in the black.

We will continue to strive in every possible way to honor the children that would not be able to dream about their future if not for the wonderful work the staff at The Tiny Tim Center provides for them on a daily basis. Thanks to each of you for your generous support of our wonderful programs!



LETTER FROM THE EXECUTIVE DIRECTOR

This time last year, I was still relatively new to The Tiny Tim Center. At that time, I commented about the 'turbulent' times the Center was experiencing as a result of significant transitions and current challenges. Those observations were followed by a commitment that The Tiny Tim Center would successfully navigate through those turbulent times and in the end once again become a strong and stable organization. Through the hard work and dedication of many stakeholders and The Tiny Tim Center staff and Board of Directors, The Tiny Tim Center celebrated many accomplishments and achieved positive strides in 2011.

With the assistance of Social Venture Partners of Boulder County (SVP), one of the Center's most significant accomplishments was the development of a new business plan and three year strategic plan. The strategic plan is comprised of three main strategic goals that will guide the Center's future efforts to long term stability and expanded community outreach:

- 1 Execute a comprehensive marketing plan (with consistent branding and messaging) that increases the diversity of our clientele and increases community awareness and understanding of all services provided at The Tiny Tim Center.
- 2 Develop and implement a sustainable and organization-wide human resources framework that attracts and retains quality professionals and fosters staff dedication and outstanding job performance.
- 3 Enhance and expand The Tiny Tim Center programs and services in ways that meet community needs, increase enrollment, promote economic and cultural diversity, and enhance the sustainability of the center.

The Tiny Tim Center is fully committed to this strategic plan. We have created numerous task force committees to seek out creative solutions, partnerships and opportunities that will allow the Center to achieve every action step contained within each of the three strategic goals.

This was only the beginning of the excitement and success in 2011. In the preschool program, our enrollment increased by 33 children in no small part to the new full day program. In addition, the demand for preschool services for children with special needs increased despite the fact that SVVSD is terminating their partnership with The Tiny Tim Center. Families are stating that no other preschool is able to offer the same low ratios and the quality services that our highly educated and experienced team has.


Our therapeutic services program continues to grow each year. In 2011, our therapists made over 6,400 visits which was just over 1,000 more than the previous year. In the midst of these visits, the therapeutic team was able to maintain its partnerships with Longmont United Hospital as well as the St. Vrain Teen Parenting Program, receive our State of Colorado Home Care Agency Class A license and implement a new web based billing system that will increase our therapists efficiencies.

We have accomplished many great things in the past year because of the great efforts and dedication of our staff and board. However, our work is far from finished. We continue to seek out new partnerships and opportunities that will allow The Tiny Tim Center to expand the reach of its mission. Current efforts include a partnership with the Wilderness Early Learning Center in Boulder and the start up of a new full inclusive private kindergarten in the fall.

The tremendous progress we have made in the past year would not be possible without the generous support of the parents, alumni, volunteers, community supporters, business and philanthropic organizations who donate their time, expertise and money to support our mission. Please accept our sincerest "Thank you!" for your continued support of The Tiny Tim Center.

FROM THE BEGINNING



The Tiny Tim Center provides comprehensive early childhood education and therapeutic services to children with special needs and typical children from Longmont and surrounding communities.

Through direct early childhood intervention with children ages 2 1/2 to 5 years, our specialized preschool services are designed to assist each child in making important developmental gains. While our preschool model has expanded to include at-risk and typical children, our goal has remained the same: to enable young children with disabilities the opportunity to maximize their potential, while minimizing the long-term effects of their challenges on themselves and their families.

In 1997, The Tiny Tim Center expanded to include therapeutic outreach services to children from birth to 12 years of age. Through this program, we are able to offer individualized motor, language and other developmental therapies in the home, at our therapeutic facility, or other community sites to enhance the development of the children and to provide support to families and strategies for continued progress. Our outreach program staff also offers support to our local hospital nursery staff and families who have infants with special needs, and they provide quarterly screenings and follow-up support to our local teen parenting program.

While our history is rich with stories of the impact The Tiny Tim Center has had on children and their families over the years, our focus must be on the future. As part of our vision, we are committed to maintaining the scope and quality of our programs, and

exploring and implementing inventive 'best practices.'







2011 PROGRAM ACTIVITIES AND HIGHLIGHTS

Developmental Preschool Program

- Served a total of 150 children. 39 of those children had special needs, while 25 were considered 'at-risk' for developmental delays.
- With assistance from the Colorado Preschool Program, we were able to offer financial aid opportunities for 9 children from low-income homes.

- Scholarships were awarded to 14 children who were also from low-income families.
- The developmental preschool hosted a monthly Parent Education Night. Topics included healthy eating habits, engaging play with your child, supporting families with special needs, transitioning into kindergarten and social and emotional behaviors.
- We expanded our relationship with Special Olympics of Colorado and implemented their young athletes program. If focuses on friendship skills, team work, empathy and fine/gross motor skill with the spirit that everyone wins.

Therapeutic Outreach Program


- We provided individualized and/or small group motor and language therapies and community support to 350 children through 6,400 individual therapeutic client visits.
 - Speech Language, Occupational, Physical and Brain Integration Technique Therapy
- We provided 3 enrichment programs in 2011—YogaKids, Tiny Tots, and Therapeutic Listening.
- We continue to be the only center in the Longmont area to provide comprehensive Augmentative and Alternative Communication (AAC) Evaluations. We provided comprehensive AAC evaluations and submitted the funding reports to insurance providers. We also began offering parent and teacher support groups and training opportunities.
- We also provided the following community outreach activities:
 - 21 visits to the Neonatal Intensive Care Unit at Longmont United Hospital, providing recommendations to families. We also participated in weekly rounds.
 - 9 hours of support to local teen parenting program, including developmental screenings, direct intervention, home program ideas and serving on their advisory board.

The Tiny Tim Center continued their partnership with Kid Connects by working with Amanda Hildenbrandt. The program is an integrated health and mental health consultative program. Amanda worked with the staff, students/clients and their families helping to work through a wide variety of challenges. It has been a tremendous resource for families.

Over 182 Volunteers provided over 4,600 hours of service and support in the following areas: Board of Directors, Board committees, teacher's assistant support, administrative assistant support, fundraising and building maintenance.



PARENT LETTER



WOW! How do I even begin to tell you how thankful I am for your facility. When I first heard of The Tiny Tim Center in 2010, I called and left a message practically begging for information. I was given hope that The Tiny Tim Center was who I

needed to talk with and I could not wait to hear what options I might have for my son. When a friendly voice returned my call... I was in tears again because I felt all alone and had no idea where to go or what kind of resources were available for my newly diagnosed "sensory child". That day I was scared and felt I had nowhere to turn. Thankfully, and by the grace of God, I was directed to The Tiny Tim Center and from that day on, my life, and the life of my son, Garrett, has been changed forever.

During the first few months of having my son attend your center, I was so conflicted and saddened because I could not stop wishing that we had been aware of your center a year before. Knowing that Garrett was already 5 years old when he entered The Tiny Tim Center, his time with you would be limited. This saddened me because I wanted him to know and grow within your walls for years... not months. Quickly, I learned to discard that feeling and embrace the full understanding and knowledge to be truly thankful of ANY amount of time that he would have within your walls. Your teachers have a heart of gold and patience beyond belief. Your facility offerings are vast and educational and I was amazed at all you had to offer.


Garrett came from a private pre-Kindergarten program in Longmont, where he was having fits of anger on a weekly basis. He was frustrated and was showing signs of "sensory" practically every day. At least 2x per week, I would receive a phone call about an "instance" and it was very common that we would receive an "Instance Report" regarding something that Garrett had done to a teacher, another student, or even himself. I was at my wits end and feeling just as helpless for the school as I was for my son. I knew it was no longer a good fit and Garrett was not receiving the support and guidance that he needed to assist with his learning and self-control. Within days of Garrett first attending The Tiny Tim Center, our lives changed for the better. There was no hesitancy for him to go to school in the mornings, he was excited and happy. I was relieved to have teachers who not only understood his behavior, but they were not afraid of it! They utilized tools that supported Garrett's needs and had the student-teacher ratio that allowed Garrett to be removed from his surroundings and taken to a quiet area for 1-on-1 assistance, if needed. But the greatest surprise was that he was no longer having emotional or physical melt-downs. Garrett was not angry or mad or frustrated like he had been before. He even was taking a nap every once in awhile and that was the major source of contention at the previous school. Something was different – and that was his surroundings. The Tiny Tim Center had what he needed.

I have been so thrilled and relieved by the success of Garrett's schooling, that within months we decided to enroll our younger son to attend pre-school at The Tiny Tim Center as well. Our younger son has no sensory diagnosis. By all means he would be considered "normal", if you can label a 3-year old boy "normal". (HeeHee) But the fact stood that I knew of no better facility that offered the student-teacher ratio, educational teaching and mental/emotional support for their students. If I believed in it so whole-heartedly for my first son, why wouldn't I want the same opportunity for learning and growth for both of my children? It has been the best decision ever.

I love The Tiny Tim Center. My boys love The Tiny Tim Center. My husband and I are forever grateful for the daily attention and support that that we have as resources from a place that genuinely LOVES my boys. What else could I ask for as a mother??? Thank you. Thank you.



The Tiny Tim Center also continues to support families in the community by restricting net assets for scholarships and financial assistance and hopes to increase this support in 2012.


